As briefly as I can, here's our story of Clark County's Comp Plan disaster:

Our rural neighbors have been crying after county commissioners stripped away their most cherished private property rights. Their families have endured that pain and loss 24 years now as shown in this 3 minute video clip: http://www.cvtv.org/vid_link/18089?start=2610&stop=2850

Their only hope is to appeal to their citizen representatives for help. Clark County's rural zoning map is so mismatched to the actual rural properties that 6/10 of Residential, 8/10 of Agriculture, and 9/10 of Forest parcels are defined as nonconforming.

Clark County's plan is worse than other counties that respect private property rights. State law is not the problem. It is our friend that requires counties to correct major problems like ours every 10 years.

Yet 3 of the 5 county councilors just adopted the same disastrous plan for another 20 years. How? Why?

Here's what happened: We listened to citizens and diligently worked for nearly 3 years and finally approved a much better plan in November that citizens finally embraced.

Then two more councilors were elected who believed that staff knows best. Within weeks, in a vote of 3 to 2, everything was repealed and reverted back to the 1994 problem plan for the next 20 years. Rural citizens were devastated as the battle for their future waged in ways that I believe were morally wrong.

No one knows the heart. So we cannot claim evil motives. But we all must fight for honesty and forthrightness. Because all county meetings are recorded and all communications are open public records, the truth is self-evident and provides ample evidence to reveal who was telling the truth and who was not.

I was a witness of what I allege were 4 major misrepresentations of the truth in 4 recorded meetings that led to the current harm inflicted upon our rural neighbors. As a last resort, I reported those alleged violations of trust and am continuing to work to correct the injustice.

Clark County's Prosecuting Attorney's office, the largest law firm in our county, is named in the alleged wrongdoing, and hired their own investigator who cannot be expected to exonerate their accuser and incriminate themselves.
