Please find attached Clark County's appeal to Superior Court of the Growth Board's decision regarding urban growth boundary expansions and the Rural Industrial Land Bank.

In addition, the Cities of Ridgefield and La Center have filed appeals of the orders on de-designation and UGB expansion. The Milt Brown properties have also appealed. In a related matter, the City of Ridgefield successfully argued in Superior Court today that a lawsuit challenging its annexation should be dismissed.

Finally, CCCU has appealed the Growth Board's adverse rulings on all 11 of its issues.
