Dear Councilors,

CCCU is submitting nine pages depicting 167 items of the "Additions to the Record". These documents were no where to be found in the Public Record of the GMA 2016 Comprehensive Plan Index. They were only submitted after a request by CCCU for a supplement of the Record, to the Western Washington Growth Management Hearing Board. The supplement was granted, because "For the Public Record" was written on the documents. Most of these documents were critical to CCCU's appeal to the Hearing Board. After a week of protest and wrangling between CCCU and Clark County's attorney, the WWGMHB finally allowed the CCCU documents to be submitted into the Record and Index. This came at great cost to CCCU. There were also hundreds of other documents parties submitted into the record, at hearings, open houses, emails, and a town hall, that never were entered into the Record or Index.

Clark County's attorney agreed that CCCU gave the testimony at a routinely scheduled Councilor public hearing, but claimed that CCCU did not intend the documents to go into the record, so they were omitted. Clearly, if CCCU had not filed for a supplement of the record, those documents would not be in the Public Record Index today, and the documents would have been lost to oblivion, forever. The same thing happened to many of the documents in the 1994 and 2004 Comprehensive Plans, particularly a set of 32 aerial photographs and minutes and notes of the original 1993 resource committees.

When the public takes it's time to testify before the Board of Councilors at a duly published hearing, or sends an email to the Council members, that information must be considered a legal document that must be included in the Public Record of that legislative body and the county records. This information is not to be "cherry picked" through, and only what county staff wants in the record, is included.

Under state law, RCW Title 42, Chapter 42.56 and Chapter 42.30, this Board of Councilors are to assure that the Clark County Public Record is protected from any influence by staff or any other party, that would allow for any loss of integrity. The Public Record must be complete according to all correspondence to the Board of Councilors or bodies entrusted under them. It is the Board's responsibility to ensure the Public Record is accurate and complete, and it is a criminal act to do otherwise. County staff blamed the faulty record on certain councilors, but CCCU's documents were submitted in an open public hearing and copies were given to each Councilor and the Clerk.

The citizens of Clark County must be absolutely assured whatever they share with Clark County Council, will be recognized, considered and archived as a legal document in the Clark County Public Record.
