For the Public Record and the Comprehensive Plan

Dear Councilors,

This attached email from Rebecca Tilton is the schedule for the week of May 15th through the 19th. There is no mention of a Planning Commission meeting that was held on May 17th, to vote on the Comprehensive Plan rural land moratorium. In addition, I have scanned all emails for both myself and Clark County Citizens United, and see no notice of this meeting, even though I signed in those emails at

every Planning Commission and County Council hearing that I attended. The sign in sheets say that by filling in the lines, the county will notify the signee of any future meetings and activities of those government agencies, Neither I or CCCU has ever received notice regarding the sporadic meetings and hearings held by the Planning Commission, and CCCU, has never received notices for both.

Now we see in the Columbian, that the Planning Commission held a hearing on the rural moratorium of the Comprehensive Plan, and voted unanimously to support it. Where was the effective public notice for such an important hearing, that affects thousands of public lives? The GMA clearly says there has to be meaningful notice and participation. This is a clear example of the under the table and behind the scenes policy making that Clark County continues to subscribe to. The Planning Commission was hand picked to support the erroneous planning agenda, and the public is not aware of what they are voting on and when. ,Clark County Citizens United, Inc. has been involved in land use and the Comprehensive Plan for decades, and currently has a pending court appeal. Yet no notice was given the organization for such an important topic. This is public discrimination and bias at it's best and worse.

Delving further into other publications to attempt to find any notice of this Planning Commission hearing, came up with no results. How the few folks who did attend the hearing found out about it, is anyone's guess. Perhaps it was from behind the scenes. There is no doubt, that this hearing would have been attended by many concerned landowners, had they only known it was happening. The county may argue that people just have to look on-line, but the likelihood of people doing that is slim, because of the inconsistent schedules from the county and the difficulty in finding them.

Clearly there is broad discrimination and bias against the rural people, and this council is allowing it to happen. This Board of Councilors are assuring that the comment to staff by planning director, Oliver Orijako, overheard by a citizen, comes to fruition, when he said, *"I don't care if I am in the courts for twenty years, I am not making any changes to the rural lands"* This sort of corrupt government has got to end.
