The *Journal of the American Planning Association* (*JAPA*) publishes research and analysis useful to planners, policymakers, scholars, students, and citizens of urban, suburban, and rural areas. It aspires to bring insight to planning the future, to air a variety of perspectives, to publish only the

highest quality research, and to engage readers. *JAPA* prefers vivid and direct writing in the active voice. We particularly seek timely papers that offer significant research news.

JAPA is interested in manuscripts that examine historical or contemporary planning experience, broadly defined, in domestic or global contexts, and that do at least one of the following:

- · contribute to the theoretical and conceptual foundation of planning;
- · improve the link between planning and successful policy implementation;
- · advance the methods used in planning practice and planning research;
- · explain empirical relationships important to planning;
- · interpret noteworthy physical, economic, and social phenomena that have spatial dimensions; or
- · analyze significant consequences of planning approaches, processes, and contexts.

Manuscript Submission and Review

JAPA publishes only original material. Manuscripts submitted for review must differ substantially from other published work by the same author or authors. Authors must disclose all related work, including professional reports and studies and online publications, whether already published or in preparation, at the time of submission. Simultaneous submission of a manuscript to other publications is unacceptable. Submission to JAPA implies the author's commitment to publish in that outlet. Please note that JAPA uses CrossCheck*TM software to screen papers for unoriginal material. By submitting a manuscript to JAPA, the author(s) agree to any necessary originality checks during the peer review and production processes.

JAPA uses ScholarOne Manuscripts (previously Manuscript Central) to track and manage manuscript submissions for peer review. Please read the <u>guide for ScholarOne</u> <u>authors (http://journalauthors.tandf.co.uk/submission/ScholarOne.asp</u>) for general instructions on beginning/continuing a manuscript submission and uploading documents before making a submission. All submissions should be made online via the Author Center at the JAPA ScholarOne Manuscripts site: http://mc.manuscriptcentral.com/rjpa. New users should first create an account. Online user guides and access to a helpdesk are available on this website.

Manuscript Preparation and Requirements

Ordinarily, manuscripts should not exceed 6,000 words of main text, excluding abstract, tables, figures, notes, and references. Only papers with clear potential for publication in *JAPA* will be peer reviewed. The editor asks reviewers to judge papers based on contributions to *JAPA* 's mission as described above; we ask reviewers to evaluate the accuracy, quality of logic, writing, and research methods as well as appeal to potential readers. The editor has final authority in all editorial decisions.

Reviewer suggestions: Authors are invited to suggest names of preferred reviewers (not from their own institution). The editor does not guarantee that suggested reviewers will be contacted to review the manuscript.

Manuscript: Authors should prepare and upload **two** versions of their manuscript. One should be a complete text with author and funding information, abstract, and figures/tables; the second document should have all identifying information (including in-text and bibliographic references by authors and funding information) redacted to allow for blinded peer review. All figures and tables should be placed at the end of the document (rather than embedded within the body of the manuscript). When uploading files to ScholarOne, authors should designate the complete manuscript as "file not for review," and the redacted manuscript as "main document."

Abstract: The first page of each document must include, using no more than 300 words, a summary of the manuscript with four subheaders: Problem, Research Strategy, and Findings; Takeaway for Practice (how these findings are relevant to and important for planning practice); up to five Keywords; and About the Author(s) information. Search engine optimization (SEO) is a means of making your article more visible to anyone who might be looking for it. Please consult http://journalauthors.tandf.co.uk/preparation/writing.asp for further guidance.

Tables and figures: In the text, indicate the appropriate location of each table and figure on a separate line, after the paragraph where it first appears. Use the form: [Figure 1 about here]. Place tables in numerical order at the end of the paper, followed by figures, with each table and figure on a separate page, each with complete title and notes. Do not embed tables in the text. Supply only tables that can be edited in MSWord or Excel. Aim to keep the overall size of the manuscript file under 2 MB.

It is the author's responsibility to secure permission for reproducing any figure, table, or extract from the text of another source. This applies to direct reproduction as well as "derivative reproduction" (where you have created a new figure or table which derives substantially from a copyrighted source). Use only EPS, TIFF, or JPG formats for image files. Be sure to include only images that will reproduce well in black and white. Authors will receive specific guidelines for submitting print-quality images if the manuscript is accepted for publication.

Author bio: Authors must also create a separate document providing information on all author(s), including full name, employer/affiliation (including department), email address, AICP status, and a one-sentence summary on each in a separate file from the manuscript files. When uploading this file, designate it as the "Author Bio" file.

Digital files: Upload only MS Word for PC files formatted to eliminate any special coding such as that created by reference citation software or mathematical equations. PDF file submissions will not be accepted.

Type and spacing: Use 12-point Times New Roman type. Double-space all copy except for tables and figures. Left justify the main text and indent first lines of paragraphs rather than spacing between them.

Notes: Use notes sparingly and keep them brief. Provide notes as a numbered list at the end of the text, not as footnotes on each page.

Citations and references: Format all citations and corresponding entries in the list of references according to the Publication Manual of the American Psychological Association, Sixth Edition (American Psychological Association, 2009), including both volume AND issue number for all periodicals as well

as DOIs (digital object identifiers) for all articles.

The Editorial Office reserves the right to reject a manuscript if it fails to follow any or all of the procedural and format requirements described here; the manuscript will not enter the review process until all deficiencies are addressed. Authors will then have to formally resubmit their revised manuscripts as a new submission; the Editorial Office will not keep the deficient submission in the system.

Copyright: If *JAPA* publishes a manuscript, the author(s) will be asked to sign a form transferring copyright to the American Planning Association (APA). 
